For volunteers, riders, and guests

**Warning: Under Colorado Law, an equine professional is not liable for an injury or the death of a participant in equine activities, resulting from the inherent risks of equine activities, pursuant to Section 13-21-119, of the Colorado Revised Statutes.**

1. Responsible Party acknowledges that there are inherent risks associated with equine activities and expressly assumes all risks associated with participating in such activities. Responsible Party acknowledges that horses are by nature unpredictable animals and are subject to behave in ways that may result in injury, harm or death to persons on or around the animal. Responsible Party for Activity Participant (and/or Event Participant's parent/guardian) agrees to hold harmless, indemnify and defend Manager, Rosie's Ranch, Mary Mosher-Stathes, their agents and employees; against any and all claims, demands, judgments, orders, costs or expenses, including attorney's fees, which may arise from or be in any way connected with participant's use of, or presence upon, the property of Manager and the facilities located thereon. \_\_\_\_\_ **(initial Event Participant or parent/guardian)**

In the event the Activity Participant is a minor child, the parent/guardian shall further indemnify, defend and hold Manager harmless from any such claims by said minor, regardless of any statute of limitations or contractual limitations of actions. \_\_\_\_\_ **(initial Event Participant or parent/guardian)**
4. In case of an accident, Event Participant, parent/guardian will be responsible for any and all costs involved in receiving medical treatment. In the event of injury, every effort will be made to contact the Responsible Party's emergency contact. Manager, its agents and employees are hereby given permission to seek and arrange medical care for minor child and/or the undersigned Activity Participant.
5. In case of an accident or contraction of covid, Activity Participant and the Responsible Party will be responsible for any and all costs involved in receiving medical treatment or rehabilitation. \_\_\_\_\_ **(initial Event Participant or parent/guardian)**
